**NOTIFICATION**

In exercise of the powers conferred by section 337 read with section 13 of the Rajasthan Municipalities Act, 2009 (Act No. 18 of 2009), the State Government hereby makes the following order further to amend the Rajasthan Municipalities Registration of Electors Order, 1974, namely:-

**1. Short title and commencement.-** (1) This order may be called the Rajasthan Municipalities Registration of Electors (Amendment) Order, 2023.

(2) It shall come into force on and from the date of its publication in the Official Gazette.

**2. Amendment of order 8.-** In clause 8 of the Rajasthan Municipalities Registration of Electors Order, 1974, hereinafter referred to as the said order, the existing para (b) of sub-clause (1) shall be substituted by the following, namely:-

"(b) at the office of the Municipality concerned and display a notice in Form 2 at the aforesaid places and at five conspicuous places in each ward including small settlements, the photographs of such display in each ward shall be sent to the State Election Commission."

**3. Amendment of order 9.-** In para (b) of sub-clause (1) of clause 9 of the said order (1), for the existing expression "10 days", the expression "15 days" shall be substituted.


