Sub :- Compliance of Govt. Order No. F.10(147)UDH/3/2008Part-III dated 6th February 2017 regarding permissions for Telecom Infrastructure.

Sir,

A meeting was held under the chairmanship of Chief Secretary, Govt. of Rajasthan to resolve various issues of granting permissions for establishment of Telecom Infrastructure as submitted by Service Providers. All concerned are directed to ensure compliance of Govt. Order dated 06.02.2017 (copy enclosed) in general and on following issues on priority :-

1. It is informed that certain Local Authorities are insisting for public notice in local newspapers to invite objections from general public which delays in establishment of Telecom Infrastructure. In this regard you are directed to take action as per 6(3) of the Govt. Order dated 06.02.2017 which states that Nodal Officer shall issue a public notice for 7 days giving details of the application and it shall be placed on notice board office and at a place near the proposed site. It shall also be published on website of the Local Body concerned.


2. Many Local Authorities raise demand note with retrospective effect for the existing installations which is not according to the order issued by State Govt. At Sr. No. 12 of the order dated 06.02.2017, it is clearly mentioned that the existing mobile towers (established prior to these orders). where permission has been obtained under any previous rules/orders shall be valid and in case where permission is not obtained shall be regularized upon submission of application and other documents by paying prescribed fees/ charges under this order.

3. In case of public complaints on the issue of radiations are not being referred to TERM Cell of Department of Telecommunication. You are directed to consult TERM Cell whenever any complaint/grievance received on the issue of radiations instead of rejecting permissions for installation of new towers.

4. Some of the Local Authorities are not granting permissions for laying OFC whereas there is a provision for laying of under ground OFC at Sr. No. 4 of the order dated 06.02.2017, accordingly Nodal Officer/Local Authority are directed to adopt issue permissions for laying of OFC.

A status report shall be sent to this department within 15 days, stating the status of applications received for installation of Telecom Towers and laying of OFC. In case there is any application is pending the reasons for pending are to be mentioned.
