
The conditions mentioned hereunder shall govern the sanction:

1. The Above rates are indicative rates with specific specification laid down in bid document. ULBs will be give contract on these rates to this contractor on same conditions and specifications.
2. As per the Notification of Government, GST effected from 1st July 2017; the above rates are final negotiated basic rates of items and taxes (GST) are exclusive as applicable.
3. Letter of Award (LoA) shall be given to successful bidder by concerned ULB directly on above rates.
4. Work order will be given by concerned ULBs as per their requirement at their level for Construction & installation of Low Cost Individual Household Toilets, Community Toilets, Public Toilets.
5. Stipulated date of start and completion will be mentioned in work order for construction of toilets in concerning ULBs.
6. Ward wise list of IHHTs/CTs/PTs to be constructed, shall be provided to contractor by the concerned ULB.
7. ARC valid for 2 years under Swachh Bharat Mission (Urban) from the date of issuance of LoI.
8. However, incentive for IHHLs are Rs 12000 per IHHL and VGF for CT/PT Rs 52267 per seat the balance required funds shall be arranged as per the Guidelines of SBM or shall be borne by concerned ULB.
9. ULBs can also construct individual toilets and CTs/PTs from other contractors as per the RTPP Act 2012 and Rule 2013 on the same conditions and specifications.
10. Geo tagging should be done by the concerned ULBs and ensure O&M of the CT/PT.

You are requested to complete the following requirements as indicated below:

1. An acknowledgement of acceptance of this LoI within 3 days from the date issuance of this LoI
2. Agreement between you and concerned ULB shall be executed at the level of ULB within 15 days from the date of LoA, after submission of requisite performance security @10% as per ITB clause 6.4.2, 6.4.3, 6.4.4 of Bid document.
3. Submit detailed work-plan at concerned ULB.
4. All the terms & conditions of Bid document and RTPP Act 2012 & Rules 2013 shall be applicable.


